TOURNAMENT HISTORY

In 1967, Lou Lewis and Rev. Clyde Verheyden suggested to the Board of Trustees of the Good Samaritan Foundation that a golf tournament would be a good way to raise funds for its nursing scholarship program. Little did anyone realize that in 2018 Good Samaritan would be hosting its 52nd tournament, celebrating as one of the longest running annual charity tournaments in Houston. At the first tournament former Longhorns Coach Darrell Royal agreed to speak at the awards dinner as well as play in the tournament. Coach Royal continued to play and speak for several years after that, including in 1970 when the tournament was moved to River Oaks Country Club from Westwood.
